2003 CCC Summer Training Camp

Current PSA Coaches are coming to share cutting-edge developments and sports science knowledge with skaters, coaches and parents. Training techniques used by international and elite competitors will be presented. Additional USFSA coaches and officials will staff the training camp

I. Skater's Track

Skaters (must have passed the Pre-preliminary free skate test) will be grouped by test level

On-ice sessions will include:

- Jump Progression from singles to doubles to triples
- Techniques for training combination jumps
- Choreography to improve the artistic mark

Off-ice sessions will include:

- Rap/hip-hop
- Conditioning

2. Parents Track— Sat. only

Parents will have off-ice sessions with noted USFSA officials to answer questions such as:

- How to maximize your skater's potential
- How skaters and parents can handle the pressures of tests and competitions
- USFSA judging and accounting— demystifying the marks

3. Volunteer Track — Sat only

4. Coaches Track

- Coaches may track with any on or off-ice session

- Please return the attached form with payment by June 14, 2003. Skater must have authorization from their primary free skating coach and /or choreographer to attend the training camp.
